Nomination Guidelines

- Nominee must be an individual or family in a crisis situation. This may be health related, emergency, or other hardship.
- Information provided must be verifiable by ATHOC Foundation.
- Nominee must be personally recommended by an employee or owner of an ATHOC Member organisation.
- Nominee must be willing for their story and the ATHOC Foundation grant to be published for public relation purposes.
- Nomination form must be completed in full and signed by an authorised officer of ATHOC Member and nominee.
- Nomination form must be accompanied by letter of support from a third party professional – eg doctor, social worker, lawyer.

How to Nominate a potential recipient

The ATHOC Foundation represents your holiday ownership organisation and regularly grants holidays or other support to individuals or families in crisis. Sometimes a break away is all it takes to brighten a life. If you have someone in mind that is deserving and eligible for nomination please follow the five simple steps below.

1. Ensure recipient meets criteria requirements
2. Confirm with recipient that they agree to the nomination
3. Obtain a letter of support from a professional who can verify nominee's situation
4. Complete a nomination form (download from our website or call us to request a form)
5. Submit completed form and letter to:
